Dear Act/Sgt. Christian Pluta:

On May 27th a Notice of Liability was submitted to Iain Rankin, Robert Strang and Zach Churchill. They were put on notice for their crimes and were requested to rescind all measures relating to COVID-19 restrictions, state of emergency and COVID-19 vaccines and associated COVID-19 vaccine passports by June 11th 2021 otherwise they would be admitting to their liability. The deadline has passed with none of the requests being addressed which is a clear admission of liability. We gave them fair warning to intervene and stop the trespass of Harm and Death on the People of Nova Scotia and they chose not to respond.

Therefore, we feel it is necessary to submit these criminal charges against the above identified people, as there is an ongoing threat of death and injury resulting from their continued promotion of the COVID-19 pandemic and the lethal injections.

For the Purpose of Filing Criminal Charges Against:

- Iain Rankin who sometimes acts as the Premier of Nova Scotia
- Zach Churchill who sometimes acts as the Minister of Health and Wellness for the Government of Nova Scotia
- Robert Strang who sometimes acts as the Chief Medical Officer for the Nova Scotia Department of Health and Wellness

They have all committed serious acts of a criminal nature against the people of Nova Scotia.

The following are the criminal charges we have identified but are not limited to:
